*RESEARCH PRIORITIES: After the April 2002 Pacific Ballast Water Group meeting held in Portland, our attempt at developing a research priority list for ballast water management was unsuccessful. The topic of research priorities was raised again at the September 2002 meeting of the Western Regional Panel on Aquatic Nuisance Species. As a result of that discussion, the PSMFC in cooperation with California Sea Grant (Karen McDowell) agreed to once again try and develop some consensus on a research priority list for the West Coast. During our last attempt at research consensus, it was suggested that the "Recommended Ballast Water Research Priorities" developed by the Ballast Water and Shipping Committee of the Aquatic Nuisance Species Task Force be used as a starting point. I therefore propose, we use the ballast water and shipping committee list as a starting point at the January meeting and determine how we want to proceed from there (i.e. endorse the shipping committee document (with changes), convene a subgroup of researchers and solicit their interests and suggestions, choose not to pursue this effort any further, etc.)
